

TERMS OF SERVICE

Overview

This website is operated by MSCHF Product Studio, Inc (“MSCHF”). Throughout the site, the terms “we”, “us” and “our” refer collectively to MSCHF. MSCHF offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our site and/ or purchasing something from us, you engage in our “Service” and agree to be bound by the following terms and conditions (“Terms of Service”, “Terms”), including those additional terms and conditions and policies referenced herein and/or available by hyperlink. These Terms apply to all users of the site, including without limitation users who are browsers, vendors, customers, merchants, and/ or contributors of content.

Please read these Terms carefully before accessing or using our website. By accessing or using any part of the site, you agree to be bound by these Terms. By agreeing to these Terms, you represent that you are at least the age of majority in your state or province of residence, or that you are the age of majority in your state or province of residence and you have given us your consent to allow any of your minor dependents to use this site.

There are no guaranteed delivery windows or ship-by dates.
We'll do our best to update consumers if there are unforeseen delays.

Return Policy

For customers outside of the European Union, we do not accept returns. International customers, including customers in the European Union, must pay for return shipping and any applicable duties, unless an error occurs on our part.

Refund Policy

We do not offer refunds.

Cancellation Policy

We do not accept order cancellations.

Customer Support Window

Address change requests will only be accepted up to 48 hours after purchase. After 60 days of purchase, we do not carry out customer service on products.

General Conditions

We reserve the right to refuse service to anyone for any reason at any time.

You understand that your content (not including credit card information), may be transferred unencrypted and involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices. Credit card information is always encrypted during transfer over networks.

You agree not to reproduce, duplicate, copy, sell, resell or exploit any portion of the Service, use of the Service, or access to the Service or any contact on the website through which the service is provided, without express written permission by us.

The headings used in this agreement are included for convenience only and will not limit or otherwise affect these Terms.

Specific Conditions for *Our Cow Angus* (“OCA”):

To participate in OCA, you must purchase one of two types of tokens: (i) Burger Pre-order Token (“Burger Token”) or (ii) Handbag Pre-order Token (“Handbag Token”). The tokens, which are limited in quantity and available only while supply lasts, are available for sale at OurCowAngus.com. The Burger Token and the Handbag Token possess both a non-revocable purchasing power and a redeemable, but non-reversible, voting power (“Salvation Vote”) as described below.

Burger Token:

- Only 400 Burger Tokens will be issued.
- A Burger Token guarantees the delivery of pre-ordered single 3-pack of frozen ground hamburger patties (“Hamburger 3-pack”) to the shipping address associated with the Burger Token’s unique shipping address code. The Hamburger 3-pack will be made from the meat products derived from Our Cow Angus’s slaughter and butchery at 2pm, Friday, March 13, 2026 (the “Slaughter Date”). Burger pre-orders will ship within approximately 30-days of the Slaughter Date.
- A Burger Token also allows the token purchaser the option to cancel their Hamburger 3-pack by submitting its unique Cow Code (“Cow Code”) into the Remorse Portal of OurCowAngus.com anytime before the Slaughter Date. Canceling the Hamburger 3-pack by this method, which is non-reversible, constitutes a Salvation Vote, which voids the delivery of the Hamburger 3-pack and forfeits any rights of ownership of a Hamburger 3-pack or any other form of remuneration. Put another way, once you

purchase a Burger Token you can't get your money back; and if you cancel your Hamburger 3-pack you won't get a Hamburger 3-pack.

- Submitting a Burger Token's Cow Code into the Remorse Portal casts a vote ("Salvation Vote") to cancel Our Cow Angus's slaughter and potentially allow Angus to live out the remainder of its natural life.

Handbag Token:

- Only 4 Handbag Tokens will be issued.
- A Handbag Token guarantees the delivery of a pre-ordered leather handbag ("Handbag") to the shipping address associated with the Handbag Token's unique address code. The Handbag will be made from animal products derived from Our Cow Angus's slaughter and butchery on the Slaughter Date. Handbag pre-orders will ship within approximately 120-days of the Slaughter Date.
- The Handbag Token also allows the token purchaser the option to cancel their Handbag by submitting its unique Cow Code into the Remorse Portal of OurCowAngus.com anytime before the Slaughter date. Canceling the Handbag by this method, which is non-reversible, constitutes a Salvation Vote, which voids the delivery of the Handbag and forfeits any rights of ownership of the Handbag. Put another way, once you purchase a Handbag Token you can't get your money back; and if you cancel your Handbag you won't get a Handbag.
- Submitting a Handbag Token's Cow Code into the Remorse Portal casts a Salvation Vote to cancel Our Cow Angus's slaughter and potentially allow Angus to live out the remainder of his natural life.

To be clear, once a Burger Token's Cow Code or a Handbag Token's Cow Code is submitted into the Remorse Portal, cancellation of the Hamburger 3-pack or Handbag, which triggers the casting of a Salvation Vote, is final and can not be changed under any circumstances. Additionally, no *purchase* of a Burger Token or a Handbag Token can be canceled, returned, refunded, or replaced under any circumstances including lost, stolen, misdelivered or damaged tokens.

Voting, Life, and Death

If, at the time of the Slaughter Date, the total percentage of cast Salvation Votes is 50% or greater, the Slaughter Date will be canceled and Our Cow Angus will be allowed to live out the remainder of its natural life. All Hamburger 3-packs and Handbags will be canceled and all Token Holders, regardless of whether they did or did not cast any percentage of Salvation Votes, will forfeit any rights to receive a Hamburger 3-pack, Handbag, or any other form of remuneration.

Alternatively, if, at the time of the Slaughter Date, the total percentage of cast Salvation Votes is less than 50%, Angus will be slaughtered and butchered, and manufacture and delivery of Hamburger 3-Packs and Handbags will commence. Token Holders who cast any percentage of Salvation Votes will not be entitled to receive Hamburger 3-packs, Handbags, or any other form of remuneration.

Please note: The four hundred (400) Burger Tokens will constitute 50% of the Salvation Vote pool and the four (4) Handbag Tokens will constitute 50% of the Salvation Vote pool. And because there is a 400-unit supply of Burger Tokens and only a 4-unit supply of Handbag Tokens, each Burger Token constitutes 0.125% of the Salvation Vote pool, whereas each Handbag Token constitutes 12.5% of the Salvation Vote pool.
